With our Announcement referenced in Ref. a, the information on the go-live rehearsals to be performed with the participation of all the stakeholders in order to maintain that our participants and the data vendors could test their preparations for the go-live of the Derivatives Market (VIOP) on the BISTECH system, was submitted and it was also stated that the rehearsals would begin on 10/08/2016. Subsequently; with our Announcement referenced in Ref. b, it was announced that the scenario and technical information documents, which featured the accessing information and the time planning regarding the rehearsals, were shared at http://www.borsaistanbul.com/en/bistechsupport/news-releases.

Since the initiation of the rehearsals, in order to rearrange the future rehearsal cycles according to the changing requirements and priorities; the rehearsal cycles, which were being performed, have been regularly monitored, the outcomes have been evaluated and the rehearsal calendar and time planning has been revised with our Announcement referenced in Ref. c and the internet announcements published at http://www.borsaistanbul.com/en/bistechsupport/news-releases respectively on 10/19/2016, 12/02/2016 and 01/13/2017.

Correspondingly; in accordance with the outcomes of the completed rehearsal cycles and by assessing the demands of the market stakeholders and by considering the remaining time until golive; the BISTECH Phase 2 Go-Live Rehearsal Calendar is revised (Annex: 1), where it is decided that the still ongoing 7th rehearsal cycle to be extended and an additional new rehearsal cycle to be performed at Ankara Disaster Recovery Center (DRC) Test Environment (8th Go-Live Rehearsal).

In this context, the 7th rehearsal cycle, which was to be completed on 02/11/2017 Saturday due to our Announcement referenced in Ref. c, is extended to until 02/15/2017 Wednesday.

After the completion of the 7th rehearsal cycle; in order to maintain that our participants prepare themselves for the 8th rehearsal cycle, the necessary connection information for Ankara DRC Test Environment for TW, FIX and PTRM users shall be shared at https://connectuat.borsaistanbul.com as before. Our participants and data vendors are expected to perform an accessing test at the Ankara DRC Test Environment on 02/16/2017 Thursday between 14:00 EEST – 17:00 EEST by utilizing the abovementioned connection information. Due to the fact that Ankara DRC Test Environment does not support co-location service, OUCH and ITCH users shall not be used during the tests in this environment.
