With the announcement numbered 2020/26, it has been announced that the BISTECH System 2.11 go-live date has been postponed to July 6, 2020 due to the extraordinary circumstances and the demand from our members, data vendors, independent software vendors and instutitional investors. It has also been announced that information regarding the availability of test environments will be provided prior to the go-live date.

All new features that are mentioned in the announcement numbered 2020/13 are ready for testing in BISTECH Member Free Test Environment. It is of utmost importance that these features are tested by our members. In addition to features mentioned in our announcement numbered 2020/13, the features below have also been added to the 2.11 scope as the go-live date has been postponed. These new features will be deployed by June 1, 2020 at BISTECH Member Free Test Environment and it will be possible to test them for three weeks.

- Mass Quote message will be added to the OUCH order transmission protocol in order to provide possibility to Quotation entry. The information regarding the message can be found at BISTECH OUCH Protocol Specification document.
- It will be possible to restrict a PTRM user to access specified risk groups of a member and make changes.
- ResetDate (tag = 21067)" field has been added to FIX API Reference Data (FIX RD) document "Security Definition (MsgType = d)" and "Security Definition Update Report (MsgType = BP)" messages. FIX API protocol documents and "BISTECH Fix Data Dictionary" have been updated in regard to the updates. Respective changes have been added to the "Revision History" section of the documents.
